**Technical Notes**

- Mississippi State Board Policy Rule 41.1 paragraph 7 states that all students in kindergarten and grades 1 through 3 shall be administered a state-approved screener with in the first 30 days of school and repeated at mid-year and at the end of the school year to identify any deficiencies in reading.
- K-3 student identified through BOY Universal Screener whose results are below grade level should be assessed to determine targeted instructional support.
- Senate Bill 2572 requires ALL Kindergarten students to be assessed at the beginning and end of the year.
- For the 2018-2019 the 3<sup>rd</sup> Grade MAAP ELA Assessment will be the assessment to determine promotion/retention.
