
Baseball-Softball Field

Bid Award Quality Control Protocols

- In compliance with State and Federal Bid Laws, we evaluate all responding bidders on their price, experience, and other variables to determine the "lowest and best" contractor for the recommendation of a contractor.
- Before the bid award, we check references thoroughly to ensure contractors have successfully completed similar-scope projects.



Construction Quality Control Protocols

- The design firm (Architect) is responsible for bi-weekly construction inspections on all in-progress projects.
- During construction, the design firm and JPS staff verify the percentage of complete work and the quality of that work. No payments are made above the amount of work completed.
- At substantial completion, the design firm verifies the proper operation of all systems and equipment to ensure all installations have been made according to bid specifications.



Construction Quality Control Protocols

- The design firm creates a "punch list" or deficiency list that outlines all remaining work, and the contractor, project manager, or any district personnel may add to it.
- After substantial completion, the contractor has 30 days to complete all punch-list items.
- After project completion, contractors have a one-year warranty period to correct any failed work.
- We have the right to pursue the contractor's performance bond for all work not completed to the specified standards.
